We offer the following services according to the network tariffs: We distribute electricity from power plants to customers, we measure electricity consumption, we are responsible for the round-the-clock outage service of network operations, and we take care of network maintenance.

Good to know about electricity taxes

Customers pay electricity tax in conjunction with distribution fees. The tax consists of excise duty on electricity and a strategic stockpile fee. All customers automatically belong to Tax Class 1, unless otherwise notified. Industrial enterprises, mining and greenhouse farms operating in the manufacturing industry can belong to Tax Class 2. Companies belonging to Tax Class 2 must submit a written certificate of their operations to the network company. Tax Class 1: 2.79372 cent/kWh, including VAT 24%. Tax Class 2: 0,07812 cent/kWh, including VAT 24%.

The user is entitled to terminate the network contract according to the Terms of Network Service.

Fuse based distribution tariffs VAT 24 %

The tariff product can be changed to another once a year.

General electricity

This tariff suits a Customer who mainly uses electricity during the daytime. In this case, usually the form of heating is other than electricity. The tariff remains the same day and night throughout the year.

* Single-phase premises with at least 3 premises in one connection (apartment and terraced houses). All other singlephase premises belong to the 3 x 25A main fuse group.

** All three-phase premises smaller than 3 x 25A belong to the 3 x 25A main fuse group.

Night-time electricity

This tariff suits a Customer who has electric heating or electricity storage-heating devices. The distribution fee is lower during night-time.

Seasonal electricity

This tariff suits a Customer, who can supplement electric heating with other alternatives during wintertime. The distribution fee is lower all summer and during nights and Sundays in the wintertime.

Suited to temporary use of electricity, for example a occasions and events.

Demand distribution tariffs VAT 0 %

Invoicing of electricity supply is based on energy measured hourly. A 20 kV delivery requires that the customer has an in-house transformer for the distribution of electricity.

In Demand Tariffs 1-3 the debiting demand of active power is defined as the average of the two highest monthly demands in the last 12 months, however, this demand must be at least 40kW. When defining the summer debiting demand in Demand Tariff 3.80% of the monthly demand is taken into account (monthly demand = the highest measured 60 minute average demand of the month). In Demand Tariffs 1-3 the debiting demand is defined as the highest average reactive demand measured monthly in 60 minutes, from which 16% of the amount of the invoiceable active power will be deducted.

In Demand tariff 4 the debiting demand is defined as the remaining sum after deducting 6,000kW from the highest 60 minute average demand measured during the invoicing month. In Demand Tariff 4 the debiting demand is the highest average reactive demand measured monthly in 60 minutes, from which 16% of the highest average active power measured in the invoicing month will be deducted.

Maintenance fees of the electricity connection (VAT 24 %)

will be charged if the Customer wants to disconnect the electricity supply and keep the connection contract valid, or if the Customer has not made a contract for electricity supply within 3 months after the completion of electricity connection. The fee is 16.11 €/month for connections of max 63 A. For connections larger than 63 A and for 0.4 kV demand connections the maintenance fee is 136.25 €/month and for 20 kV it is 453.94 €/month.

* Own consumption payments are determined according to the valid Fingrid price list. Latest update 01.01.2022. By 'own consumption' is meant the proportion of produced energy consumed behind the connection point and which is not supplied to the network company. Own consumption does not mean internal electricity use by the power plant.

** If the power plant's nominal power is smaller than 50 kVA, no distribution fee will be charged.
